Management Department

The approval of credits through certification examinations such as the Practical English Proficiency Test, TOEFL®, TOEIC®, and IELTS which are other types of learning specified separately by the Minister of Education, Culture, Sports, Science and Technology as stipulated in Article 30, Paragraph 1 of Hiroshima University General Provisions (hereafter, General Provisions) shall be administered as follows.

- (1) Foreign language skills tests, etc. eligible for approval
  - 1. Practical English Proficiency Test (Eiken)
  - 2. TOEFL® test
- 3. TOEIC® public test and the TOEIC® IP test approved by the Hiroshima University Institute for Foreign Language Research and Education
  - 4. IELTS
- (2) Approved Class Subjects and No. of Credits
  - 1. Practical English Proficiency Test (Eiken)

### (3) Application Method and Range of Credit Approval

- 1. A person who acquired a prescribed level or score after admission who intends to receive approval for credits based on stipulations set forth in Article 30, Paragraph 1 of the General Provisions shall submit the Application for Credit Approval for Foreign Language Skills Tests, etc. to the school of enrollment along with the certificate or certification of score (as a rule, the original) within 2 weeks after classes start each semester.
- 2. Applications shall be approved only for class subjects for which credits have not been acquired at the time of application.
- 3. Approval shall only be given for credits and a performance assessment shall not be included.
- 4. The number of approved credits for each class subject shall be limited to 1 credit.

5. In cases where approval is sought for class subjects in which a student is currently registered at the time of application, a change in registration content for the said class subject shall be either "credits not required" or "cancellation of completion."

## (4) Application

- 1. This administration of credit approval shall be applied to enrolled students from FY2017.
- 2. Notwithstanding the stipulations set forth here, the provisions in force for Administration of Credit Approval for Foreign Language Skills Tests, etc. shall remain applicable to students enrolled prior to FY2016.

## **Supplementary Provisions**

1. Administration of Credit Approval for Foreign Language Skills Tests, etc. shall be discontinued (approved by the Director of Headquarters for Liberal Arts Education on January 31, 2017).

Supplementary Provisions (May 29, 2020 Partial Revision) This revision shall be applied from April 1, 2021.

Supplementary Provisions (November 5, 2020 Partial Revision) This revision shall be applied from April 1, 2021.
